MARYLAND'S APPROACH



- Maryland *ad hoc* Committee on Oil
- Professionals from all facets of the Petroleum Industry
 - <u>State Regulators</u> UST prevention and remediation, air quality, weights and measures, and fuel quality
 - <u>UST Owners</u> municipal, fleet, emergency generator, refiners, distributors, jobbers, and dealers
 - <u>Contractors</u> and <u>Consultants</u> in installation, maintenance, testing, and remediation
 - Manufacturers of tanks and equipment
 - Trainers and Academics
 - Even <u>Attorneys</u>

WHY WAS THE GROUP FORMED?

- The 1971 Maryland General Assembly required The Department of Natural Resources to establish a program to prevent and combat oil spillage
- The *ad hoc* Committee on Oil Spills began meeting in 1973 to establish cooperation and learning
- Continuous operation since the 1970s



STRUCTURE OF THE GROUP

- Open to anyone
- The committee meets six to eight times per year
 - Typically at MDE office
 - ~60 people attend
- Leadership from industry
 - MDE is member of the committee but not formally part of the leadership
 - Maintain independence of the organizations

Benefits Derived from Members

- Learning and discussion to get everyone working from the same information
- Task groups to dive deeper and make recommendations
- Informal discussion after the meeting
- Spread the word to the people who don't make the meeting

PENNSYLVANIA'S APPROACH

Storage Tank Advisory Committee

WHY WAS THE GROUP FORMED?

- Created by act of PA legislature (Storage Tank and Spill Prevention Act of 1989)
- Members appointed by Secretary of DEP
- Purpose was to have representation of regulated community in any rulemaking process.
- Originally had 11 members with no alternates.
 - Problems
- Current membership is 16 members (currently 15 sitting members)
- First meeting was February 23, 1990

STRUCTURE OF THE GROUP

- Group make up
 - PA State Association of Boroughs
 - County Commissioners Association
 - PA State Association of Township Supervisors
 - API of Pennsylvania
 - Pennsylvania Petroleum Association
 - Petroleum Retailers and Auto Repair Association, Inc.
 - PA Chemical Industry Council
 - Tank Installers of PA
 - 4 members from the public at large
 - Registered Professional Engineer
 - Hydrogeologist
 - Active Commercial Farm Owner/Operator

NOMINATION PROCESS

- When vacancy exists
 - Storage Tank Division Chief solicits membership
 - Reviews qualifications
 - Submits nomination packet to Secretary for approval
- Current term is 4 years
 - Notice of expiration is provided
 - Reappointments follow same process

MEETING PROCESS

- Four meetings are scheduled throughout the year (quarterly)
- Storage Tank Division Chief develops agenda
- STAC Chairperson runs the meeting
- Open to public
- Meeting schedule published online and in *PA Bulletin*

Benefits Derived from Members

- Discuss and learn about:
 - New techniques and technology
 - Current issues regarding storage tanks
 - Enforcement issues
- Provide input
- Review progress with regulatory agenda
- Establishes subcommittees to assist with proposals (fees)
- Develop key relationships and contacts in the regulated community

- Respect for all participants
- Two-way exchange of information
- Update on current events
- Willingness to listen
- Common goal

REAL WORLD SCENARIO

- At 12/8/15 and 6/7/16 meetings, PADEP presented concepts and listened to STAC members present concepts that they would like to see incorporated into Chapter 245
- The STAC was also afforded the opportunity to review and discuss draft proposed regulatory language at the 12/6/16, and 3/7/17 meetings
- On 3/7/17, the STAC voted to unanimously support the proposed amendments
- On 5/17/18, draft final-form regulatory language was reviewed and discussed with STAC. At that time, the STAC voted to unanimously support the amendments for publication as final-form rulemaking

WELCOME TO DIVISION OF STORAGE TANKS

In accordance with the Department of Environmental Protection's mission, the Storage Tank Program will protect Pennsylvania's air, land and water from storage tank releases and provide for the health and safety of its citizens. Storage Tank Program staff will work as partners with individuals, organizations, governments and businesses to prevent releases from storage tanks and restore our natural resources when releases do occur. Under the <u>Storage Tank and Spill Prevention Act</u>, which became effective on Aug. 5, 1989, the Storage Tank Program is responsible for developing and implementing regulations for above ground and underground storage tanks. Specific program responsibilities include the following: tank registration and payment of an annual



responsibilities include the following: tank <u>registration</u> and payment of an annual registration fee, <u>certification</u> of tank handling and inspection individuals and companies, <u>permitting</u> of tanks, establishment of technical and operational standards for <u>aboveground</u> and <u>underground</u> storage tank systems, and procedures for reporting of releases and <u>corrective action</u> by tank owners.
