

New Mexico is multilingual



New Mexico has:

The highest percentage of Hispanic people, 49% The third highest percentage of Native people, 11% 34% of people speaking a language other than English at home (Spanish, Diné)



NMED's Public Involvement Plans

- PIPs required for all actions that involve public participation
- PSTB translates all public notices into Spanish



- NMED requires the use of EPA's EJScreen tool to determine extra public outreach and translation needs
- PIPs also require outreach to any nearby tribes, colonias, or land grants



NMED's Translation Efforts

- The NM Environment Dept. hired a professional Spanish translator in 2018
- The Petroleum Storage Tank Bureau (PSTB)'s e-blasts have been translated into Spanish since December 2017
- PSTB's goal since 2017: translate all documents for the public into Spanish
- 2021: Brochures translated into Arabic and Urdu at inspectors' request

La Oficina de Tanques de Almacenamiento de Petróleo (Oficina) requiere que los propietarios/operadores de tanques de almacenamiento de petróleo demuestren responsabilidad financiera para tomar medidas correctivas y para compensar a terceros por lesiones corporales y daños a la propiedad causados por liberaciones accidentales que surjan de la operación de los sistemas de tanques de almacenamiento de petróleo según lo requerido por 20.5.117 NMAC.
