






# ILLINOIS EPA LUST AT A GLANCE

- Total Incidents Reported-30,197
- Incidents Closed-25,294 (83.7%)
- Total Incidents Still Open-4,903
- New Incidents 6 to 8 per/week
- Incident Closed 7 to 9 per week
- Steady???

- Analyzing existing Illinois EPA LUST data
- Extracting data from LUST and Fire Marshal into Qlik
- Evaluate information on open LUST sites
- Looking thru different lenses
- Identifying opportunities to address open sites
- Implementing new strategies



• Multiple open incidents at a single site

- ≻17 incidents at Great Lakes Naval Station 17 incidents
- ≻7 Scott Air Force Base 63 incidents
- ≻6 Argonne National Laboratory 17 incidents
- >3 City of Springfield DPW − 3 incidents



- 1,055 open incidents never assigned a PM Done
- 1,007 open incidents, PMs no longer in the program Almost done
- 3,220 (62%) open incidents, no EJ determination Almost Done



- 2,515 (49%) open incidents are in Chicago Metropolitan Area
- 1,701 (33%) open incidents are in Cook County, one out of 102
- 3,256 (63%) open incidents have never submitted claims
- Single PRP with most open incidents 7-Eleven/Speedway
- 127 incidents with \$100,000 deductible



#### **External Factors**

- Inactive/non-responsive owner/operator
  - Chicago Metropolitan Area (49% of total open incidents)
  - Cook County (33% of total open incidents)
- Multi-Agency involvement
- DoD and other federal sites
- Resources with string attached
- Prevention Aging tanks

#### **Internal Factors**

- Property owner vs. owner/operator
  - Enforcement takes time
- Missing documents
- New incidents vs. closure, hard to keep up
- Not enough staff
