COURSES QUALIFYING FOR DEP RECERTIFICATION/REINSTATEMENT - CONTINUING EDUCATION HOURS



Maine law requires a contractor filling or disturbing soil in the municipal shoreland zone have a DEP-certified individual responsible for erosion and sediment controls on-site each day until the site is permanently stable. Individuals must complete approved Continuing Education Hours to maintain certification.

- REINSTATEMENT** (of expired certifications beyond 6 months)

Please note that additional credit hours are required for expired certifications to be reinstated. To become reinstated, additional Continuing Education Hours will be required and afford you certification until December 31 of that calendar year. Certifications expired less than one year need one credit hour for reinstatement, 1-3 years since expiration requires 2 credits, and 3 credits are needed if expired beyond 3 years (valid until end of calendar year, grace period applies).
